Dustin and Sara -

Hi – I went into the saved draft GovDelivery notice for the PQC one I created for you about 3 weeks ago.

I opened up the Word file that Jim forwarded to me and noticed that it is a lot different from the original GovDelivery notice I created several weeks ago. In the bottom of the email it asked to update 3-4 dates, but when I looked at the GovDelivery notice I created for you several weeks ago – there are no dates included in the original email notice.

To help cut down the extra time on this –

- 1. After you read this email, I am sending you both a TEST message of the notice I did for you several weeks ago and you can compare it with the Word file that was attached in Jim's email earlier today.
- 2. Once you compare the 2 write-ups what exactly would you like done in terms of updating the DovDelivery notice?

Is the Word file supposed to be used instead of the original notice I put together several weeks ago? The content in the Word file is twice as long as the original notice I created. If my hunch is correct – Here is some guidance that I will toss at you to consider –

If you want to use all the content in the Word file – I strongly suggest shortening it to about 2-3 paragraphs AND then I can create/update the CSRC News item to include ALL the text in the Word file.

If you/we use all that content in the GovDelivery email notice, our subscribers will not want to read such a long notice – save it for the webpage (long content).

Let me know – I haven't updated anything yet.

Just wanted to run my thoughts and suggestion to you.

I think having a short GovDelivery email notice will go a long way and then I/we can provide a link to the longer announcement either on the CSRC News page and/or maybe a PQC project news page could be created?
