Hi Meltem-

You should be aware that before submitting an article to JRES for their consideration, it must go through the ERB review process and be approved by them first before you can submit to JRES.

Honestly, I think it would be highly unlikely to get a quality paper drafted and through ERB within the next 17 days. Remember that you're also going to be competing (in ERB) with other publications for review time from division and ITL management, during the final 2.5 weeks of the FY.

The deadlines for JRES (submissions by 9/30, and final JRES article published by 12/31) are solid and cannot be changed.

As far as other venues go, it depends on the style of the article. But NISTIR is the most obvious candidate IMO, given that's where we've published our reports on rounds of the SHA-3, Lightweight Crypto, and PQC projects. An overview of the entire SHA-3 project would seem to fit there, too.
