For example I cannot use dropbox inside NIST firewall. Do other members have experience besides Gorjan on slack? Sometimes it is an additional burden to introduce a new tool. We use "sharepoint" before, which is completely "internal". It cannot be accessed when you are out of NIST domain. If slack allows us to share something out of NIST domain, I think that might be a problem, even not for IT security, for our confidentiality of the document we can only share internally. Let's further discuss.
