Hi, Dustin,

This is a hard decision. Not sure how the travel will be. Maybe you can call the travel office and ask about traveling to Malta, e.g. whether you need a visa if you use official passport and any Covid specific requirements. [International Travel | NIST Intranet](#) You may also look at the airlines to see how you can fly there. (I traveled to Malta many years ago. I remembered it was Chicago – Roma – Malta, not a direct flight.

It really depends on how you feel to deal with the international travel. It sounds complicated. If you like to go, let's try to see if we can get everything through on time. If you do not feel like to travel now, just tell them that we are under CR and it takes time to get the travel approved. Therefore, you like to use virtual talk option as a backup at least. (This is true. You do need it.)

I think the procedure is more or less the same as before the pandemic. I will submit the request to Matt and then to ITL. You use E2 to get reservation. Please let me know

how you think. The in-person talks are good to get feedbacks and to meet people. The virtual talks will save your energy and avoid uncertainty due to the Covid. (We did not have managers' meeting today. Otherwise, I would have asked Matt again about travel budget.)

It sounds like NIST has started to allow people who have fully vaccinated to travel. But it is not clear whether our division has determined about how much we can spend on the travel during the CR.
